1. Introduction

1.1 Purpose

This release is compatible with Microsoft Dynamics 365 for Finance and Operations release 10.0.39, platform version 63 or later.

1.2 Audience

This document is intended for new or current RapidValue partners and customers. Some knowledge of the Microsoft Dynamics 365 for Finance and Operations and prior versions of RapidValue is assumed.

1.3 Certificate renewal information

As an Independent Software Vendor, we provide you with licenses which can be used to enable/use our solution. These licenses are based on a Microsoft certificate which is part of our solution. The security certificate, that expires every 3 years, ensures that our customers have valid Staedean software installed and not an unlicensed copy. This digital check is executed during installations and upon installing the license files, ensures that they have legitimate software installed. The previous security certificates for Staedean solutions would expire on June 9, 2023. This release (and releases beyond) contains the new certificate and a new feature within the Solution Management Workspace. After installing the update, the security certificate renewal can be completed in 3 simple steps.

Step 1: Install the update and navigate to the Solution Management Workspace

Step 2: Click the 'Retrieve available licenses' in the action pane.

Step 3: Validate the licenses for correctness and completeness and click import.

1.4 Deliverables

1.5 SHA256 algorithm for licenses.

You may have already been informed by Microsoft, that licenses that are generated using the SHA1 algorithm will no longer be supported starting at Microsoft Dynamics 365's F&SCM version 10.0.39.

As we currently use the SHA1 algorithm for our licenses, there is an action for you to take to ensure you can continue using our services. We introduce the new SHA256 algorithm for our licenses, which will be supported going forward by Microsoft.

What do you need to do before updating to version 10.0.39?

- 1. Please go to the Solution Management Workspace in your F&SCM environment
- 2. Retrieve and install these licenses based on the SHA256 algorithm. You can find a guide on how to do that under this link
- 3. After retrieving and installing the new license, you can upgrade to version 10.0.39 without any interruptions to our services.

1.6 Product release information.

RapidValue 10.0.44.52 for Dynamics 365 Finance and Dynamics 365 Supply Chain Management (10.0) is built upon D365 version 10.0.39. Since Microsoft maintains a no breaking changes policy, the fact that this release is built on this version means that it can be applied to an environment running on D365 version 10.0.39 or any later version and the application should compile without any issues. However, as we have only functionally validated this version against D365 version 10.0.44, we recommend applying our Staedean product release on that MS version as well. If you deviate from this (and thus apply the release to a different version), we recommend performing a more thorough round of testing before applying the release to a production environment.

2. What's New in RapidValue BPM Suite

2.1 Change requests on 10.0.44.52

RapidValue version 10.0.44.52 includes the following additions:

- New data entity related to the requirement table and its relations
- Enabled the hyperlink navigation on the "Test run" column of the "My test runs" form

2.2 Unnecessary history records

As part of changes introduced with 10.0.43.50, related to the copying attachments with released RV solutions, unnecessary history records were created during the "Release solution" operation.

In specific scenarios, this caused longer execution time for batch processed. The issue has been fixed in the RV version 10.0.44.51 and an additional clean up script is included in the build. After updating to 10.0.44.51, it is recommended that users use the script to remove the affected records by appending the following parameters to their environment URL as shown below.

Running the script will remove history records related to released solutions, that are not usually created during the regular processes of RV.

2.3 Microsoft DLL deprecation

Microsoft is deprecating the Microsoft.WindowsAzure.Storage namespace, thus minor code changes were made in order to address it in release 10.0.43.50. The functional part of RV is not affected.

2.4 Additional field in Rapid Value under requirement type " Data Migration"

When creating a requirement and assigning that to a business process ,now additional field i.e. Data Migration is added to drop down menu. Now user can select a requirement type as Data migration. You can short the requirement based on a type.

2.5 Moving multiple flow elements in a single task.

When publishing documentation from RV, the sequence of the elements is important. This defines the sequence in which the element explanations/descriptions are shown in the published

documentation. By default, the element sequence is the sequence in which the elements are added to the flow. However, most of the times, that's not the desired sequence. So, you have to manually change the sequence.

When changing the element sequence for a flow, you often have to move several elements up or down. However, earlier you can only do so one element at a time. Now you can move several elements in one go.

2.6 Added where-used fact box to Concepts.

A Concept can be a be used in different business processes, Activities, Flow and concepts. By using Where used fact box to that concept a user can get to know the information about that particular concept.

Modules \rightarrow RapidValue \rightarrow Business Process Modeling \rightarrow Business Model \rightarrow Concept



2.7 Enable references to RapidValue elements of the same type.

When you are working with Concepts, Flow or Activities. You can add references to it under "See also" tab. Now you can add references to that element of same type. For example a flow can have a sub element as flow.

2.8 Support for multiple languages.

At Staedean, we are constantly working to upgrade our solutions and also encourage customers to participate by sharing feedback. We had earlier launched an in-app feedback option in our D365 solutions, where our customers can share their feedback and requests while using our solutions. We did receive multiple requests for translations in other (European) languages. We picked the most requested languages and added it to our roadmap.

Previously we do support Canadian-French language and as of 12-Apr-2023, we do support the RapidValue in 10 different languages out of the box. The user interface is, as part of the strategy, available in the next languages: English (US), German, French, Spanish, Portuguese, Dutch, Italian, Norwegian, Swedish, Danish.

Staedean is using the Microsoft Dynamics 365 Translation Service for automated translations of user interface elements. In our solutions we use standard labels and new solution specific labels. The standard labels are already provided with translations done by Microsoft. The solution specific labels are now also available to users in more languages.

As we used automated translations and reused existing labels it might be the case that some translations are wrongly translated. With a single translation unit the AI powered translation service is not aware if it should be translated as noun or verb. Some words do have multiple meanings, like "application". It could be related to recruitment or a software solution. If you come across such issue, please use the in-app feedback or create a support case, so we can improve the translations for future releases.

If you are in the need for other languages or your business requires a different term, you can extend the label files with a small development effort.

If you have customizations on the translations in your current environment,

check if this is done in a separate extension model and correct extension naming convention. If e.g. the name of the Staedean label file in the English language is TILabel.en-US.label.txt, the new translation in German provided by Staedean will get the file name TILabel.de.label.txt. Ensure in your customization will then have a naming convention including the keyword extension. A German extension label file has then the name TILabel_extension.de.label.txt. The extension labels will have priority above the standard provided labels. You can also choose to remove your labels and uptake our new standard translations.
